- Social Security Cards for you, your spouse and dependents. (You **MUST** have originals or a letter from the Social Security Administration. No copies permitted.)

- Wage and earning statement(s) Form W-2, W-2G, 1099-R from all employers
- Any interest & dividend statements from banks (1099 forms)
- A copy of last year's federal and state returns *if available*
- If you have a bank account, the routing number and account number for Direct Deposit (bring a blank check or bank statement)
- If you pay a daycare provider, the total amount paid and the provider's tax number
- Any charitable contribution or higher education expense receipts, or interest paid statements (1098 forms)
